The Patriot Freedom Festival is held each year on the Saturday and Sunday of Memorial Day weekend. It is a community event open to all with no charge for admission. It has a military theme with reenactors providing encampments that were typical of past wars, a valuable history lesson for all. Obviously, there is a strong Civil War overtone since the VA Campus is a direct result of that war and the desire of President Lincoln to provide a home for returning soldiers to heal from their wounds. Approximately 10,000 people attend the event each year.

The Grotto was created in the old quarry where limestone was removed to construct the original buildings on the Historic Dayton VA Campus. Originally known as the Soldiers' Home, it was created in 1865 along with two others Milwaukee, WI, and Tongas, ME to provide a place where soldiers returning from the Civil War could rest and heal their mental and physical wounds. The soldiers, at the urging of one of the doctors, created the Grotto in the old quarry. It contained beautiful gardens, lakes, and a spectacular arched entry, all designed to provide a peaceful place to reflect and heal. It became a major attraction for the community with events to showcase the beautiful gardens created by the veterans. Over time, neglect and funding allowed the Grotto to deteriorate. About 5 years ago, members of our organization and the community began the process of restoring the Grotto to its original beauty and tranquility. It is once again a community attraction and a place of healing for our veterans with severe injuries and PTSD.
